

Privacy Notice Regarding the Use of Personal Data
by ADVENTURE HOUSE S.R.L.

This privacy notice aims to inform you in a transparent, concise, and simple manner about how we protect your personal data. On May 25, 2018, Regulation (EU) 2016/679 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, known as the General Data Protection Regulation (GDPR), came into effect. The protection of natural persons with regard to the processing of personal data is a fundamental right. Regulation (EU) 2016/679 aims to ensure a consistent and high level of protection of personal data. In accordance with Regulation (EU) 2016/679, we inform you about the following:

1. The operator processing personal data:

Our company, ADVENTURE HOUSE S.R.L., headquartered at 40 Upper Nisipului Street, apt. 2, Braşov County, with a branch located at 60 Carpaţilor Street, Braşov, registered in the Braşov Trade Register under no. J08/3919/15.12.2022, fiscal registration code RO47318338, represented by Emil Roată, in his capacity as administrator, as the Operator, will process the personal data you provide to us in accordance with the relevant legal provisions concerning the protection of personal data, as well as the provisions of this privacy notice. Regarding all matters concerning the processing of personal data, you have the possibility to contact the data protection officer, who will respond to any inquiries or requests you may have regarding the processing of your personal data. The data protection officer designated by ADVENTURE HOUSE SRL is Mr. Emil Roată, who can be contacted by email at climbhouse.brasov@gmail.com.

2. Purpose and legal basis of personal data processing

We may collect, use, transfer, disclose, store, or otherwise process the following categories of personal data:

- **Personal information:** name, surname, series, number, and expiration date of the identity card, date of birth, age, data provided by you at the time of signing the Internal Regulations of the Climb House Center, authentication in the Climb House application, and, if applicable, signing the participation agreement for the minor accompanying you to the activities of the Center.

- **Contact information:** email address, phone number necessary to personalize future communication, respond to your requests, and send you information related to the services provided by our company.

The Operator processes only personal data that are relevant, adequate, and limited to what is necessary for the performance of the contractual obligations assumed.

The processing of personal data is necessary for your participation or that of the minor(s) you accompany in the activities of the Climb House Center.

The processing of the aforementioned personal data will be based on your freely given consent expressed by signing the "Declaration of Consent regarding the processing of personal data". In case we will process personal data for purposes other than those presented, we will inform you in advance of the purpose of that processing.

3. To whom do we communicate personal data?

The operator collects personal data directly from you at the time of signing the Climb House Center's internal rules, authenticating in the Climb House application, and, if applicable, signing the agreement for the participation of the minor you accompany in the activities of the Center.

The personal data you provide for participating in Climb House Center activities is processed only by personnel authorized by the Operator for this purpose and may be disclosed only to competent public authorities authorized to oversee the Operator's activities.

4. The retention period for personal data

The Operator retains personal data in accordance with the legal principles of personal data processing, specifically for a period necessary to fulfill the purposes for which they were processed, with a maximum duration of 5 years.

5. Your rights, as provided for in Articles 15-21 of the Regulation, include:

- a. The right to know what data is being processed, to have access to it, and to request a copy;
- b. The right to request the deletion or correction of data;
- c. The right to restrict processing;
- d. The right to data portability;
- e. The right to object;
- f. The right to receive the personal data you have provided to the Operator in a structured, commonly used, and machine-readable format, and the right to transmit this data to another operator.

6. You have the right to withdraw your consent for the processing of personal data at any time. Providing personal data is necessary for the purposes mentioned in point 2 above, so withdrawing consent makes it impossible to participate in the activities of Climb House Center.

Withdrawal of consent will not affect the legality of data processing carried out before withdrawal.

7. You have the right to lodge a complaint with a supervisory authority if you believe that the processing of personal data is being carried out in violation of the provisions of General Data Protection Regulation no. 679/2016 (<http://www.dataprotection.ro>).

8. Profiling

The Operator does not process data for profiling purposes and will not evaluate data based on automated processing.

9. How we protect your data

The security and protection of personal data are ensured by adhering to a set of internal policies and procedures updated periodically to meet new requirements. We have implemented measures to enhance the security of data processing. In the event of a personal data breach, we will inform the Supervisory Authority and the data subject about the security incident.
